

Ordinance No. 2022-01

**ORDINANCE AMENDING SALARY ORDINANCE OF THE TOWNSHIP OF
ALLAMUCHY, WARREN COUNTY, STATE OF NEW JERSEY**

BE IT ORDAINED, by the Mayor and Council of the Township of Allamuchy as follows:

Section I

1. The salary ordinance of the Township of Allamuchy is hereby amended by adding thereto the following:

POSITION	Minimum	Maximum
Clerk 1/Telephone Operator	\$18.00 per hour	\$25.00 per hour
Water Treatment and Sewage Plant Assistant Operator	\$18.00 per hour	\$30.00 per hour

Section II

1. Any salary, wage or compensation not mentioned in this Ordinance shall remain the same as previously provided.

2. Payment of the salaries mentioned above shall be payable from the date on which employment commenced and shall be made pursuant to resolution of the Township Council.

Section III

1. Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.


2. All ordinances or parts of ordinance inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.




