

**Ordinance No. 2022-03**

**ORDINANCE AMENDING SECTION A311-19 OF THE  
ALLAMUCHY TOWNSHIP CODE CONCERNING  
MEMBERSHIP ON THE BOARD OF COMMISSIONERS OF THE SPECIAL  
MUNICIPAL SERVICES DISTRICT**

WHEREAS, it is necessary and appropriate to amend Section A311-19 of the Allamuchy Code, setting forth the qualifications for membership on the Board of Commissioners of the Special Municipal Services District (SMSD), to clarify the provisions governing the appointment of members of the Panther Valley Property Owners' Association ("PVPOA") to the Board of Commissioners and to correct a typographical error in Section A311-19..

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Township of Allamuchy as follows:

**Section I**

Section A311-19(A)(1) of the Allamuchy Township Code is hereby amended to read as follows (deletions are stricken through):

Whenever a vacancy occurs for any reason among the two Commissioner positions to be filled by resident members of the PVPOA, the PVPOA shall submit, in its sole discretion, a list of three resident members of the PVPOA. A resume for each individual on the list will be submitted. The initial term of Commissioners shall be two years for one of the Commissioners and one year for the other. Thereafter, the term for PVPOA Commissioner shall be two years, as set forth below.

**Section II**

Section A311-19(A)(a) of the Allamuchy Township Code is hereby amended to read as follows (additions are in boldface, deletions are stricken through):

At any given time, there ~~may shall~~ be one but no more than one PVPOA Commissioner who is also an acting Trustee of the PVPOA. A former Trustee and an acting Trustee may hold office at the same time. If during his or her term a Commissioner is elected or appointed as a Trustee, said individual must resign his or her appointment as Commissioner within 20 business days of his or her becoming a Trustee.

**Section III**


1. Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

2. All ordinances or parts of ordinance inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

3. This ordinance shall take effect immediately upon adoption and publication according to law.
