**ORDINANCE CONCERNING SALARIES, VACATIONS, AND HOLIDAYS, AND OTHER WORK CONDITIONS FOR OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF ALLAMUCHY, WARREN COUNTY, STATE OF NEW JERSEY**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Allamuchy as follows:

**Section I**

1. The following official employment designations are hereby confirmed and the range of compensation of each officer and employee of the Township of Allamuchy shall be:

Additional compensation by way of holiday pay, longevity, overtime, sick days, personal days, insurance benefits, and other matters related thereto are as set forth in Chapter 46 of the Allamuchy Township Code and hereby incorporated in this ordinance.

2. This ordinance shall supersede and replace any and all prior Salary Ordinances and Amendments thereto. Upon the effective date of this Ordinance, any and all prior Salary Ordinances and Amendments thereto and all salaries and compensation authorized therein shall have no further effect. The within Ordinance represents the salaries and compensation to be received by all current, exiting employees and offices or those anticipated to be filled in the near future. In the event that an existing office or position is currently vacant, and a salary or compensation is not set forth in this Ordinance, this Salary Ordinance shall be amended to create a salary and/or salary range for such position or office prior to said position or office being filled.

## Section II




2. All ordinances or parts of ordinance inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.




