**ORDINANCE OF THE ALLAMUCHY TOWNSHIP MAYOR AND COUNCIL
DISSOLVING VISION COMMITTEE, AND REPEALING CHAPTER 10, ARTICLE IV
OF THE ALLAMUCHY TOWNSHIP CODE**

WHEREAS, the Allamuchy Township Mayor and Council have determined that it is in the best interests of the Township and its residents to dissolve the Vision Committee, and to repeal the provisions of the Allamuchy Township Code pertaining to that Committee.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Township of Allamuchy as follows:

Section I

The Allamuchy Township Vision Committee is hereby dissolved.

Section II

Chapter 10, Article IV (Sections 10-32 through and including 10-39 are hereby repealed.

Section III


1. Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

2. All ordinances or parts of ordinance inconsistent with this ordinance are hereby repealed as to the extent of such inconsistency.

3. This ordinance shall take effect immediately upon adoption and publication according to law.




